Here are a few answers to frequently asked questions that may help you determine the appropriate approach for your gift:

Minimum dollar amount required to endow a scholarship: \$25,000

Ways to endow/fund the scholarship:

Gifts can be made outright as cash or appreciated stock, or through a multi-year pledge. Also, scholarships can be endowed through a bequest or other charitable giving instruments (gift annuities, trusts, etc.)

Distribution of an endowed scholarship:

Generally, scholarship awards are distributed one year after the full gift amount has been received. This allows time for the investment to generate an appropriate amount of interest that serves as the scholarship.

Selection of recipients:

The Gustavus Financial Aid Office selects the recipient(s), based on the criteria established by the donor.

Determining parameters or restrictions:

The Office of Institutional Advancement helps donors determine appropriate requirements.

Strictness of restrictions:

Scholarship awards based on academic merit and/or financial need without additional restrictions are strongly encouraged. Since programs at the College are subject to change over the years, it's prudent that donors determine criteria that will provide for flexibility.

Length of distribution to one recipient:

Generally, a student retains a scholarship throughout his or her academic study at Gustavus Adolphus College as long as he/she remains in "good academic standing."

What you receive:

Gustavus honors its endowment donors with gratitude and public acknowledgements of their vision and support by providing donors with annual reports on financial performance and scholarship awards. Students are also encouraged to write thank-you notes to their benefactors and donors, and also meet with them whenever visits can be arranged.
